2. CANCELLATIONS –

Less than 60 days, forfeit 50% of trip fee
 Less than 30 days, forfeit 100% of trip fee
 NB: Credit card fees incurred by MBDE will not be included in refunds

3. LUGGAGE ALLOWANCE – Maximum weight of any bag on any expedition = 25kg(55lbs). Multiple bags allowed on non fly-dive itineraries only.

4. TRAVEL INSURANCE CONDITION - I understand unforeseen work, medical or airline problems may cause me to cancel this expedition. Compensation for: expedition cancellation and lost or damaged bags or equipment must be claimed against my travel insurance. Weather or mechanical problems may cause the itinerary to be changed or cancelled. No refund is offered for time lost due to: weather; the medical evacuation of a passenger or reduction of dives due to bad weather. Under no circumstances is compensation offered to change flights or holiday plans.

5. MEDICAL STATEMENT - I state that I am in good health for diving. I do not have asthma, diabetes, epilepsy or a heart disorder. I will not dive on your expedition if I am feeling unwell or I have a chest cold or respiratory congestion. I understand if I have any medical condition contrary to these requirements I must produce a diving medical certificate completed by a diving medical specialist.

6. MEDICAL EVACUATION – I understand in a dive or medical emergency I am responsible for the cost of evacuation. I authorize you to make medical and transport arrangements as may be determined in my best interest. I agree to pay expenses incurred on my behalf, which may be charged against my credit card.

Mike Ball Dive Expeditions recommends you:

- Ensure your travel insurance specifies medical evacuation and support for scuba diving.
- Or purchase DAN membership for dive and other emergency support at www.danasiapacific.org
- Australian residents can check to see if their ambulance service will pay the cost of a diver evacuation.

7. GUIDED DIVES - Most of our guests prefer to dive independently with a buddy. It is not our policy for all dives to be divemaster led. We provide complimentary orientation dives to enhance skills; a scheduled morning & afternoon guided group dive & the opportunity to dive with our staff on an ad hoc basis.

8. DIVE EXPERIENCE – I agree if my dive experience / expertise is inadequate for a dive I will not participate in that dive and I will follow the crew's instructions.

9. EQUIPMENT – Manufacturers recommendations & specifications must be followed in respect to equipment maintenance, assembly, pre-dive checks and emergency procedures.

10. IMAGE RELEASE – Unless I advise to the contrary I authorize MBDE to use as they see fit any photographic, video or digital images taken on this expedition in which I appear, have entered into the photographic competition or supplied to MBDE.

11. EQUIPMENT AGREEMENT - I agree to reimburse Mike Ball Dive Expeditions (referred to as MBDE) for any of their diving equipment lost or damaged whilst in my care.

DISCHARGE OF LIABILITY - It is a fundamental condition of this contract between MBDE, its employees and agents on the one part and (**print your name**)
